License Grant & Scope

- **Demol License:** Upon download, AffordableFonts.com grants you (the Licensee) a perpetual, non-exclusive, and non-transferable Demo License to use the Font Software for your personal projects. A full Commercial License can be purchased from AffordableFonts.com
